 - 1. Home Rule Bill Update: No new information

- 7. SPED Director Report
 - 1. Outplaced Student -
 - 1. Berkshire Hills, \$29K tuition (extremely reasonable!) with \$62k (\$450/day) in transportation costs (only company available is coming from Chicopee). Discussion and vote at next meeting re: reallocation of funds and use of circuit breaker funds to cover costs.
